Dealers are expected to man their table during advertised public hours.

Space allocated to an applicant **MAY NOT BE SHARED OR SUBLEASED.**

Applicants shall remain responsible financially and otherwise for the transactions at their tables. Only **registered** dealers or their staffs are allowed behind tables. The club reserves the right to expel any dealer or individual who violates set rules or conducts himself in a manner unbecoming the dignity of our local, state or national organizations without refund of fees paid. This show is strictly invitational and the club officers may deny any application. Primary applicant must be a Greater Jacksonville Coin Club Member, your annual membership fee is included as part of your bourse fee.

Membership is not required for additional staff working your tables.
